

NOTICE OF MAKING OF AN ORDER
HIGHWAYS ACT 1980
DENBIGHSHIRE COUNTY COUNCIL
(LLANARMON YN IAL 59)
PUBLIC PATH DIVERSION ORDER 2023

The above order, made on 21st February 2023, under section 119 of the Highways Act 1980, will divert the existing length of footpath described in 1) below to a different line described in 2) below.

1) Description of existing footpath.

That section of Public Footpath 59 in the Community of Llanammon yn Ial in the County of Denbigh commencing at an existing point on Footpath 59 just after the footbridge, at point A on the Order plan at OS Grid Reference SJ 18373 58794 and running in a north westerly direction for approximately 114.3 metres to point B on the Order plan at OS Grid Reference SJ 18316 58887 it continues north westerly for 46.7 metres to Point C on the Order plan at the lane known as Chapel crossroads to A494, at OS Grid Reference SJ 18303 58930. Crossing the lane from point C and travelling north easterly for 24.4 metres to point D on the Order plan at OS Grid Reference SJ 18323 58942, continuing northerly for approximately 64.8 metres to Point E on the Order plan at OS Grid Reference SJ 18330 59006 the path continues in a north easterly direction for approximately 102.1 metres to point F on the Order plan at OS Grid Reference SJ 18384 59091 and finally north easterly again for approximately 152.6 metres to point G on the Order plan at OS Grid Reference SJ 18494 59192.

As shown by a solid brown line between the points marked A-B-C-D-E-F-G on the map contained in the Order.

2) Description of new route.

Which shall be diverted to a different line commencing from a point on existing path 59 just after the footbridge at point A on the Order plan at OS Grid Reference SJ 18373 58794 and runs north easterly for approximately 138.5 metres to point H on the Order plan at the public road known as Chapel crossroads to A494 at OS Grid Reference SJ 18392 58932. The path continues north across the lane for approximately 7.37 metres to point J on the Order plan at OS Grid Reference SJ 18392 58939 and then north easterly for approximately 84.3 metres to Point K on the Order plan at OS Grid Reference SJ 18418 59019. The path continues north (over the culverted ditch at Point L on the Order plan at OS Grid Reference SJ 18430 59107) then north easterly for approximately 113.3 metres to Point M on the Order plan at OS Grid Reference SJ 18442 59128 and then again north easterly for approximately 78.6 metres to Point N on the Order plan at OS Grid Reference SJ 18496 59185 then finally north westerly for approximately 6.8 metres to Point G on the Order plan at OS Grid Reference SJ 18494 59192.

As shown by green dashes between the points marked A-H-J-K-L-M-N-G on the map contained in the Order.

If the Order is sent to the Welsh Government for confirmation any representations and objections which have not been withdrawn will be sent with the Order.
